

Honeywell Announces Obsolescence of EV15 and EV12 1D Scan Engines

Honeywell introduced the 1D Imager Series more than 15 years ago. Over the years, Honeywell has identified and re-qualified new sources for obsoleted components to maintain the product line. However, today, we announce the end-of-life of the EV15 and EV12 1D Scan Engine product line as the critical component, the microprocessor, is being obsoleted by its supplier.

Honeywell recommends its customers and partners move their 2D Scan Engine designs to the Honeywell N4680 Series Compact, Decoded 2D Scan Engines in order to maintain a close form factor to ease the migration. Please reach out to your local sales contacts to discuss a detailed migration plan.
